

MINUTES OF A REGULAR MEETING OF  
THE MAYOR AND CITY COUNCIL OF  
THE CITY OF HAMILTON, ALABAMA

May 3<sup>rd</sup>, 2010

A regular meeting of the Mayor and City Council of Hamilton, Alabama was held on Monday, May 3<sup>rd</sup>, 2010 at 6:00 p.m. in the Auditorium of Hamilton City Hall. Mayor Holliday called the meeting to order and welcomed all guests. Scotty Sanderson led the Pledge of Allegiance and McDavid Franks gave the Invocation. Those present were:

The first order of business was a motion made by McDavid Franks that the minutes from the last meeting be approved. Scotty Sanderson seconded the motion which passed unanimously.

The next item on the agenda was a recommendation to pay the Accounts Payable Bills after examination by the Council. Annette Sherrill made a motion to approve the recommendation and Scotty Sanderson seconded the motion. All voted in favor.

Annette Sherrill made a motion to authorize Mayor J. Robert Holliday as the voting delegate for the City of Hamilton at the May 18<sup>th</sup> League Business Session for the annual Municipal League Convention in Mobile, Alabama. McDavid Franks seconded the motion which passed without opposition.

The next item on the agenda was a recommendation to remove the \$10,000 cost clause from the section of the Building Permit Ordinance concerning roofing. The fee will be \$.05 per square foot for the replacement of shingles, re-surfacing or re-tarring of a structure per square foot of the building regardless of the cost of the job. This will not apply to roofing jobs involving construction. Paul Stidham made a motion to approve the recommendation and McDavid Franks seconded the motion. Voting was as follows: Ayes: Annette Sherrill, Paul Stidham and McDavid Franks. Nays: Scotty Sanderson.

Annette Sherrill made a motion to adopt and utilize the Marion/Winston Assign a Highway Program administered by Northwest Alabama Council of Local Governments, wherein roadsides are cleared of litter by probationers in lieu of fines and jail time. The cost of the program is \$1,500.00. City Judge Wyatt Howell will make the recommendations as to who qualifies for the program. McDavid Franks seconded the motion and all voted "Yes".

McDavid Franks made a motion to accept the low bid of \$19,780.75 from Precision Communications, Inc. for Weston weather siren and also the low bid of \$60,895.00 from Tri-County Construction for culvert replacement on 1<sup>st</sup> Street. Bids were opened May 3<sup>rd</sup> on each project. Scotty Sanderson seconded the motion which passed unanimously.

McDavid Franks made a motion to approve the "Stop Work" order issued by the City of Hamilton to be sent to individuals who are in violation of City Zoning Ordinance number 2010-4 and Building Code Ordinance number 2009-21. Paul Stidham seconded the motion which passed without opposition.

Annette Sherrill made a motion to promote Officer Scotty Chandler to Investigator for the Hamilton Police Department. Scotty Sanderson seconded the motion and all voted "Yes".

Paul Stidham made a motion to approve the new Hamilton Police Department Procedure Manual. Annette Sherrill seconded the motion which passed unanimously.

At this time Mayor Holliday encouraged everyone to fill out their census forms. Annette Sherrill stated if you did not receive a census form someone from the census bureau will be visiting them at their residence.

There being no further business, Scotty Sanderson made a motion that the meeting be adjourned. Annette Sherrill seconded the motion, following a unanimous consent in favor Mayor Holliday declared the meeting adjourned.
